PAYMENT OF FEES

You will receive one Fee Statement for Total 2023 Tuition Fees, Levies and Charges.

3 payment options are available.

Option 1: Payment of school fees in FULL due by **7 April 2023**.

Option 2: Direct Debit to be lodged within 2 weeks of fees being issued, to commence prior to **7 April 2023**, and to be finalised by 31 October 2023.

Option 3: BPAY or EFTPOS, a minimum of 25% of fees to be paid each Term and account paid in full by 31 October 2023.

Direct Debits are due in full by October 31st, 2023. Any arrangements past this date must be made with the School Principal.

TUITION FEE DISCOUNT

Second child	20% discount on Tuition Fees.
Third child	40% discount on Tuition Fees.
Fourth and subsequent children	100% discount on Tuition Fees.

HEALTH CARE CARD

If you are the holder of a means tested Health Care Card, or Pensioner Concession Card – Parenting Payment Single allowance, you are entitled to an automatic discount on the Tuition Fees. It is important to note that the card must be in the name of the person responsible for the payment of the fees. If there is joint responsibility for the payment of the fees, the discounted rate applies only to the eligible card holder. Families eligible for the Health Care Card Discount Scheme need to present their card to the office and complete a form by **28 February 2023**.

AMENITIES

This fee is a fixed annual charge per student. This covers items such as photocopying, art/craft, and classroom resources required throughout the year.

INCURSION/EXCURSION LEVY

This fee covers students for any performances/incursions/excursions that students attend throughout the year.

CURRICULUM LEVY

This fee helps to offset costs of purchasing Curriculum area resources used by the students. Literacy and Numeracy subscriptions are covered by this levy.

TECHNOLOGY LEVY

This fee helps to offset costs of purchasing technology equipment and updated software programs for use by the students.

BUILDING LEVY

The Building Levy is a fixed annual charge per family.

CATHOLIC PARENTS PRIMARY SCHOOL ASSOCIATION LEVY

This membership supports CPPSA to be a voice for Catholic schools, in particular in obtaining public funding for Catholic Schools. This membership also supports FOSPS to access best practice initiatives within P&F groups around the state for education and community relationship purposes. This is not a fundraising levy for the school.

PARENTS & FRIENDS LEVY

The P&F Levy is a compulsory levy **maintained by the P&C**. All contributions go directly to the school to help provide educational materials, enrich classroom learning, purchase new classroom equipment and update school grounds to help our students learn, thrive and achieve their best.

SCHOOL FEES: SETTING & COLLECTION POLICY (2-C12)

As per the School Fees: Setting & Collection Policy, all Levy Payments are non-refundable. Families are charged Tuition on weekly basis, regardless of how many days are attended in the week. All other levies are calculated on a Term by Term basis, regardless of how many weeks are attended in the Term. PFFWA Levies are charged annually per student with no refunds for attending less than the whole school year. Consumables are not refundable.
